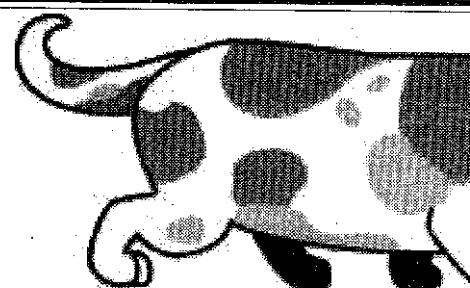

## New co credit i

More parents and students will qualify for tax credit over the two years under American Recovery Reinvestment (ARRA).

"If you're planning to attend college this fall, take a look at the American Opportunity Credit," advised Clay Sanford, a Dallas-based IRS spokesman. "It's a new credit that replaces and expands on the Hope Credit."

The American Opportunity Credit modification allows existing Hope Credit tax years 2009 and 2010, making the Hope Credit available to a broader range of taxpayers, including many with higher incomes and those who owe no tax. It also requires a course matriculation to the list of qualified expenses and allows credit to be claimed for four post-secondary education years instead of two. Many of those eligible will qualify for a maximum annual credit
